
with Space and Microgravity Science, and holds a patent for a component of a breakthrough industrial instrument.

Dennis Struk – Dennis Struk's earliest recollections are of being raised, with six brothers and sisters, in a two room shack in northern Saskatchewan. There was no running water, no modern conveniences, but there was an old record player and Hank Williams Senior became a life-long inspiration. At age six, Dennis received his first guitar and by twelve, he was barn-storming across the prairies with an old time dance band. At age 15, he left home and worked in the Alberta oil patch for four years before heading to Winnipeg to pursue his career. Dennis formed a group called the Majestics and was scheduled to perform on the CBC television show, 'Don Messer's Jubilee.' That show was never recorded. Messer, who had become a great Canadian legend, passed on before the band's television debut. For two years, Dennis played back-up with Marg Osbourn, who also appeared on the Don Messer Show. And he played for Bob Regan and Lucille Starr, who penned a tune called "The French Song". These days, Dennis is kept occupied promoting two newly released cassettes - "Coming Back" and "At It Again". He tours Canada from coast to coast and throughout North America, meeting friends both new and old. "I am not a stranger, just a friend you haven't met," says Dennis. "I thank everyone for your support and kind consideration."

Millie Strueby – I have been playing in a dance band since the 70s and did some travelling around Saskatchewan. Connected Canadians is a federally registered non-profit organization that provides technology training and support to Canadian seniors, fostering digital literacy skills and reducing isolation and loneliness.

Through partnerships with senior communities and other senior serving organizations, we

provide remote one-on-one training sessions, volunteer training and workshops.



Connected Canadians has onboarded over 250 volunteers who speak over 20 languages which allows them to work side-by-side (remotely) with older adults and seniors to tackle various technology-related goals, learn new skills, or accomplish any learning objectives at their own pace with a strong focus on patience, empathy, and connection. This mentorship also provides companionship to older adults who are often isolated and without the necessary digital literacy skills to connect to family, friends, and community.

Ken oversees the Connected Canadians team, ensuring that the internal team is fully supported so that they can best serve Connected Canadians' clients. He also engages with Connected Canadians' partners, maintaining healthy relationships and ensuring the smooth delivery of workshops and other services designed to boost digital literacy. Besides his leadership roles, Ken also volunteers his time to provide technology mentorship to Connected Canadians clients. He draws on more than 10 years of experience in the hospitality industry to deliver the highest level of service in any role he undertakes. Ken graduated from

Carleton University with a Bachelor of Commerce and is a passionate musician and DJ in his free time.



## Resolutions

## **Resolution Concerning Financial Support for Dental Services for Saskatchewan Senior Citizens**

WHEREAS the cost of dental care prevents many senior citizens accessing badly needed dental treatment, including fillings, extractions, crowns, full or partial dentures, and more; and

WHEREAS oral health can contribute to several conditions and diseases, such as endocarditis, cardiovascular disease and pneumonia; and

WHEREAS the Federal Government has introduced the interim Canada Dental Benefit which is currently available to families earning less than \$90,000 per year, but which currently applies only to children under twelve years of age, and which will not be extended to adults and seniors until at least 2025; and

WHEREAS most provincial governments provide some level of dental care coverage for low-income seniors, some even including oral surgery and dentures; and

WHEREAS current low-income eligibility thresholds (in other provinces ranging from annual incomes of \$19,000 for individuals to \$27,000 for couples) are so low that many lower-income people are excluded; and

WHEREAS costs of private dental coverage are expensive for coverage which is often very limited; and

WHEREAS Saskatchewan does NOT cover routine dental services for seniors, or anyone else;

THEREFORE BE IT RESOLVED that the SSAI approach the Government of Saskatchewan and urge it to quickly institute a program of dental care which includes routine dental services, extractions, oral surgery and fuill or partial dentures for all seniors; and

THEREFORE BE IT RESOLVED that such a dental program be available to all Saskatchewan seniors, but on a sliding scale of benefit based on income, with individuals with incomes of \$30,000 or less receiving 100% payment coverage.

**Be it Resolved:** that non-profit organizations, including seniors' groups, be exempt from paying the federal carbon tax on heating and energy costs.

**Background:** Most non-profit organizations in rural Saskatchewan are struggling to remain viable due to the rising cost of living and declining populations. Seniors in rural areas struggle to maintain their premises, pay their utility bills and taxes and still enjoy a social life, which the Seniors' groups provide.

**Arguments:** Since individuals and corporations receive a carbon tax rebate from the government, why is there not a mechanism in place for non-profit organizations that also pay the carbon tax on heating and energy costs.

Moved by Judy Lawes Seconded by Brian Masear -- Dinsmore Gaiety Group

#### Re: Bylaws: Article 3 – Members at Large (2.)

Moved by Lorraine Thibeault (Club #68); Seconded by Bruce Clements (Club #68) THAT 'members at large' shall not be entitled to a vote at the Provincial Convention.

#### Reasoning:

- 1. The 'member at large' does not represent anyone but themselves. A vote gives them a lot of power as compared to a Club voting delegate who represents a large number of members when they vote. Since the 'member at large' must join a Club within one year, he/she should wait until the time that they are a Club member when they may be elected to be a voting delegate for the Club.
- 2. The Provincial Executive could approve as many 'members at large' as they wish; they could approve people who hold certain views that the Provincial Executive wants to see moved forward and therefore influence the outcome of a vote at Convention. This could negate the voice of the 'Club' delegates who represent a large number of members.

#### Re: New Bylaw

Moved by Lorraine Thibeault (Club #68); Seconded by Bruce Clements (Club #68) THAT a member not hold two or more of the positions of Provincial President, Director and Co-ordinator at the same time except for the short time (1-2 months) between the District, Regional and Provincial Annual Meetings when elections are held.

#### Reasoning:

- 1. A variety of people in these positions will allow for a broader spectrum of views, skills and will encourage a shared work load. Grass-roots members will have greater representation.
- 2. A variety of people in leadership positions allows for more accountability. For example, let's say that a co-ordinator, who is also a regional director, does not hold a required meeting or a required election in his/her district. After approaching the co-ordinator, if nothing changes, the Club members would need to approach the director to share their concerns... but the director is the co-ordinator whose action or lack of action they are concerned about. This is not a good situation.
- 3. This applies to the Director position as well if the Director is also the Provincial President. If the Director does not follow the Constitution & By-laws and does not do so after being approached by the members, who do the members approach to remedy the situation? They would have to approach the Provincial President who is also the Director who is not following the Constitution & By-laws. Again, this is not a good situation.

#### Re: Bylaws - Region - Article 10 (2.)

Moved by Lorraine Thibeault (Club #68); Seconded by Bruce Clements (Club #68) THAT Bylaw – Region - Article 10 (2.) be rescinded and replaced by the following: THAT the Region leadership (Regional Council) will be comprised of a Director, Secretary Treasurer and the Co-ordinators of each District within the Region.

The Director will be elected yearly at the Annual Regional Meeting from amongst to

The Director will be elected yearly at the Annual Regional Meeting from amongst the registered members of the Clubs comprising the Region.

The Secretary/Treasurer will be appointed by the Regional Council.

The Co-ordinators will be elected from amongst the registered Club members in the District at their respective Annual District Meeting.

Reasoning: At the present time, with the exception of District 6a, Regions have three districts and, therefore, three co-ordinators. Only the present Co-ordinators may run for the position of Director.

#### With the new motion:

- 1. We would have a broader pool to choose from for nominating and electing a director.
- 2. It will allow the Director to focus on one position and not be forced into holding two positions (i.e.) Co-ordinator and Director, at the same time.
- 3. It will allow for more representation from throughout the Region

#### Re: Review of SSAI Handbook, Constitution & Bylaws

Moved by Lorraine Thibeault (Club #68); Seconded by Bruce Clements (Club #68) THAT the SSAI Handbook, Constitution & Bylaws be reviewed at least every two years with the first review beginning six months prior to the upcoming convention (December 2023), and THAT Club members be approached at the beginning of the review so that they may submit suggestions for changes to the above.

#### Reasoning:

- We always experience change over time and sometimes these changes need to be reflected in our Handbook, Constitution and By-laws. Covid19 is an example of a drastic change. The on-line participation in the Provincial Convention is a good example of positively dealing with a situation which affected our attendance at Convention.
- 2. Constitutions and Bylaws sometimes prove to be ineffective. Rather than continuing with ineffectiveness and inefficiency, we should be prepared to change in a timely manner... not five or ten years down the road.
- 3. I, Lorraine Thibeault, am willing to recruit members to form a committee to review the Handbook, Constitution and Bylaws and to investigate why many members aren't interested in taking on leadership positions. I am also willing to lead that committee. If, at Convention, the voting delegates agree with this, then a motion should be made stating THAT a committee be formed to review the Handbook, Constitution & Bylaws of the SSAI and THAT they bring their recommendations to the 2024 Convention of the SSAI. That way, the committee will have the authority to contact members to gather their suggestions for additions, deletions, and retaining what is working for us. All recommendations would then be brought to all members attention in a timely manner for consideration at Convention.

"No one wants to take on a leadership position!" When I began inquiring about the shortage in leadership, I was informed that "no one wants to hold a leadership position" and that is why so few people are holding many of the positions and why elections aren't being held. If this is the case, then I believe that we have a "leadership crisis". We need to consider the following: "Why do so many people not want to hold a leadership position? Is the SSAI not following its mandate? Has the leadership become clique-ish in a way that discourages others from taking on leadership positions? Are we expecting too much of the people taking on leadership positions? Is the SSAI effective in representing the grass-roots members?" There

could be many reasons why we are struggling to get people to take on leadership positions. Let's investigate why we are in the situation that we are in and try to resolve it before the SSAI fades away.

Moved by Lorraine Thibeault (Club #68); Seconded by Bruce Clements (Club #68) THAT the Provincial SSAI Executive take greater care to ensure that those in leadership positions follow the SSAI's Constitution & Bylaws.

#### Examples when this has not happened:

- 1. <u>Election to Office</u>: Article 8 "each district will elect a co-ordinator to hold office for one year." This means that the co-ordinator's position ends after one year. In a timely manner, registered members in a District, through notification to the Clubs, should be informed of any vacancies (end of terms) and of an upcoming election and asked to submit nominations or offer their own name to stand for the position of co-ordinator. At this time, the present co-ordinator could decide to let his/her name stand for the position. He/she would go through the election process the same as anyone who lets their name stand for the position. If only one person lets his/her name stand for a position, then an election is still held and the person is 'elected by acclamation.'
  - a. It would be advantageous for some members to form a nominating committee to seek candidates and to run the election. If the incumbent is letting his/her name stand for a second term, that person should not be part of the nominating committee and should not run the election.
  - b. It would be useful for Clubs to receive a biography/write-up of each person who is letting their name stand for the position of Co-ordinator, Director and Provincial President so that Club members can make an informed decision of who would be best for the position. They can then instruct their voting delegates to vote in accordance with the Club's wishes.
  - c. At the present time, in some districts/regions, no one is ensuring that elections are being held annually. The incumbent is staying in the position without being elected to another term and without the position being advertised as open so that others may allow their names to stand for election.
  - 2. <u>Formation of a District Council</u>: In the SSAI Handbook, it is "strongly recommended" that district councils be formed. When this doesn't happen, who encourages the district co-ordinator to form such a council?

- Gentle exercises (one hour a day, one day a week November to April; two days a week from May –
  October)
- Games of Choice (three hours a day, one day a week throughout the year)
- Crafters' Choice Chatter Day (one day a week from September to May). At these days, a variety of crafters use the hall to quilt, paint... whatever craft they do personally while they socialize. It runs from 9 a.m. to 4 p.m.
- Line Dancing (1.5 hours a day, one day a week from September to May)
- Kaiser card game (three hours a day, one day a week throughout the year)

#### Monthly, we hold the following events:

- SLGA-approved Bingo 1<sup>st</sup> Monday of each month
- Club Meeting with birthday/anniversary cake & celebration 2<sup>nd</sup> Monday of each month
- Teas once a month In 2023, we have had a Welcome 2023 Tea (January), a Valentine's Tea (February), a St. Patrick's Tea (March), a Spring Tea & Quilt Display (April), and a Mother's Day Tea & Tea Cup Display (May). In June, we'll have a Father's Day Tea. We average 50 attendees at our teas.
- Old-time Dance & Potluck Snacks once a month with a live band. We average 50 attendees from all over the area with many from Prince Albert. It's a joy to watch the quick steps of these dancers and to be able to sway our bodies and tap our toes to the old-time fiddle tunes.
- At the bingos, teas and dances, we hold SLGA-approved 50/50 ticket sales.

We have held one major SLGA-approved raffle on a lap quilt (\$150 value) donated by one of our members, and we are in the process of raffling a basket of fishing supplies (\$200) donated by another of our members. Over the past year, we held a Pancake Supper and a Chili Lunch as extra fundraising events and a Christmas Supper as a social event.

We have our first outing away from Shellbrook planned for June 8 when we will hit the Little Red hiking trails near Prince Albert. Having a designated organizer for 'away-from-home' events has increased the likelihood of many more similar activities.

We had eight walk-a-thon participants and registered a total of 2,570.68 km. We hope to have more participants next year.

We participate in a variety of service projects:

- Valentines for Vets we make home-made Valentine cards and send them to Veterans Affairs to be distributed to veterans in care homes.
- Quilts for the Homeless we collect old jeans, filet them and send the jean material to a Girl Guides of Canada adult group which uses the material to make quilts which they distribute to homeless people in Prince Albert
- We collect items for the Prince Albert YWCA Homeward Bound project. Items are distributed to homeless women who drop in to the YWCA for the night because they have nowhere else to go.
- Members drive seniors to appointments out of town.
- Get well, birthday and thank you cards are sent out by our Sunshine chairperson.

We begin our regular meetings with the singing of O Canada and The More We Get Together. Our AGM was well run. We had only one director position to fill. The rest of the terms end March 31, 2024. At that time, our President will have held the position for two consecutive 2-yr. terms, so we will have a new president as, according to our bylaws, the present president cannot hold the position again until another term has passed.

"Our Place' is the name of our Seniors' Centre. We rent our hall for public functions including funerals, baby and wedding showers, yoga and other exercise programs, quilt retreats and meetings of other organizations at a rate of \$25 per hour. Our kitchen rents for \$40 an event. Rentals are picking up once again after the Covid19 slump but not enough to cover our expenses. Our insurance for the hall is high and caretaker and utility costs have increased. We do not want to lose 'Our Place', so we have been fundraising and applying for grants to help us keep our building. Some of our newer members have been investigating the SSAI handbook, constitution & bylaws as they consider what the organization is all about. They have shared some of their concerns with the Club members. The Club has decided to look into the benefits (or lack thereof) of belonging to SSAI. Our elders remember a time when the SSAI did 'good work,' as they say, and they have asked the newer members to take this year (2023-24) to see if we can experience some benefits of belonging to the SSAI as well as contributing to the SSAI. We have also become concerned with SSAI non-compliance with their own by-laws in the area of elections. After attending our District Meeting #4 where no nominations were asked for, no election was held for the position of Co-ordinator, and the incumbent simply kept the position, this increased our concerns about the SSAI. Some members have passed on their concerns in the form of motions to be considered at the 2023 SSAI AGM. In a year's time, the Club will decide whether it will continue to belong to SSAI.
